WARNING: Powerboat racing has inherent risks, which may result in serious injury or death.

Driving a powerboat in racing conditions involves inherent risks; death, dismemberment, head and spinal injuries, drowning and other serious injuries that can require treatment, hospitalisation and rehabilitation. Boat racing events, may be conducted at a site that is remote, either by time or distance or both, from a treatment facility. Powerboat racing is a physically strenuous activity and you will be exerting yourself during race events. You must advise truthfully and fully inform race officials including rescue and recovery personnel of any significant medical issues including any prudent past medical history.
