Pit Area:

Adequate covered footwear must be worn by all team members and spectators wishing to enter the pit area.

No smoking/naked flames or consumption of alcohol is allowed in the pit area.

Any team found to be in breach of these rules will be disqualified from the event and asked to leave the pit area.

Each boat will have an area of 3m and allowed to have 1 tow vehicle in the pit area to reduce congestion of the area.

Please ask all visitors to park in the top car park.



Scrutineering:

Scrutineers will be available on Friday afternoon.

All boats must be scrutineered prior to 9am Saturday 30th July.

State Boating Licence and Boat Registration documentation must be shown at both scrutineering and nomination when requested.

Cell Test Confirmation letter from within the last 12 months must be provided for any cell boat. Each boat can only enter one class.

Drug and alcohol Testing:

All drivers must complete a breath test prior to racing each day. Random testing may take place throughout the weekend and all drivers and crew will be asked to comply.

I agree, at all times, to abide by the directions, rules and regulations from the Officer of the Day and will comply with the requirements under the Transport Operations (Marine Safety) Act 1994, and Transport Operations (Marine Safety) Regulations 2004. Equipment or inspections required by such rules or legislation, cannot guarantee the safety of my equipment, or myself and in some circumstances may make it more dangerous.
5. I do not rely upon inspections of vessels and equipment required under Bundaberg Powerboat Club Incorporated rules, to find any faults with that equipment.
6. I accept full responsibility for any person/s who are in my care.

I understand and agree that my safety is my own responsibility.

WARNING: POWERBOAT RACING HAS INHERENT RISKS, WHICH MAY RESULT IN SERIOUS INJURY OR DEATH.

Driving a powerboat in racing conditions involves inherent risks; death, dismemberment, head and spinal injuries, drowning and other serious injuries that can require treatment, hospitalisation and rehabilitation. Boat racing events, may be conducted at a site that is remote, either by time or distance or both from a treatment facility. Powerboat racing is a physically strenuous activity and you will be exerting yourself during race events. The "Released Parties" may not be held liable or responsible in any way for any injury, death, or other damages or loss to me, my family, estate heirs or assigns that may occur as a result of my participation in this powerboat racing event program or as a result of the negligence of any party, including the Released Parties, whether passive or active.

In consideration of being allowed to participate in this race meeting, I hereby personally assume all risks of driving in these race events, whether foreseen or unforeseen, that may befall me while I am participating in this powerboat racing event, including but not limited to testing, warm-up sessions, racing activities, dangerous behaviour and emergency diver retrieval from my race boat and water.

I further release, exempt and hold harmless said Released Parties from any claim or lawsuit by me, my family, estate heirs, or assigns, arising out of my enrolment and participation in this event including both claims arising during the event or after I have finished my events for the day.

I also understand that driving a powerboat in racing conditions is a physically strenuous activity and that I will be exerting myself during this event, and that if I am injured as a result of heart attack, panic, drowning, head injury or any other cause, that I expressly assume the risk of said injuries and that I will not hold the Released Parties responsible for the same.

I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or guardian.

I understand the terms herein are contractual and not a mere recital, and that I have signed this document of my own free act and with the knowledge that I hereby agree to waive my legal rights.
