Driving a powerboat in racing conditions involves inherent risks; death, dismemberment, head and spinal injuries, drowning and other serious injuries that can require treatment, hospitalisation and rehabilitation. Boat racing events may be conducted at a site that is remote, either by time or distance or both, from a treatment facility. Powerboat racing is a physically strenuous activity and you will be exerting yourself during race events. You must advise truthfully and fully inform race officials including rescue and recovery personnel of any significant medical issues including any prudent past medical history.

I understand that driving a powerboat in racing conditions involves inherent risks; death, dismemberment, head and spinal injuries, drowning and other serious injuries that can require treatment, hospitalisation and rehabilitation. Boat racing events may be conducted at a site that is remote, either by time or distance or both, from a treatment facility. Powerboat racing is a physically strenuous activity and you will be exerting yourself during race events. I still choose to proceed with such powerboat racing activities in spite of the possibility of injury and or death caused by or resulting from my own conduct during an event.
I understand this Liability Release and Assumption of Risk Agreement (Release) hereby encompasses and applies to all boat driving activities in which I choose to participate in as part of powerboat racing events.

The 'Released Parties" may not be held liable or responsible in any way for any injury, death, or other damages or loss to me, my family, estate heirs or assigns that may occur as a result of my participation in this powerboat racing event program or as a result of the negligence of any party, including the Released Parties, whether passive or active.
In consideration of being allowed to participate in this race meeting, I hereby personally assume all risks of driving in these race events, whether foreseen or unforeseen, that may befall me while I am participating in this powerboat racing event, including but not limited to testing, warm-up sessions, racing activities, dangerous behaviour and emergency diver retrieval from my race boat and water.
I further release, exempt and hold harmless said Released Parties from any claim or lawsuit by me, my family, estate heirs, or assigns, arising out of my enrolment and participation in this event including both claims arising during the event or after I have finished my events for the day.
I also understand that driving a powerboat in racing conditions is a physically strenuous activity and that I will be exerting myself during this event, and that if I am injured as a result of heart attack, panic, drowning, head injury or any other cause, that I expressly assume the risk of said injuries and that I will not hold the Released Parties responsible for the same.
I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or guardian.
I understand the terms herein are contractual and not a mere recital, and that I have signed this document of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree if any provision of this Agreement is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.
